This is a Contract between Meow, Bark and Board, INC and the pet "Owner."

1. Owner agrees to pay the rate for pet care (board) that is in effect on the day the pet is checked in.
2. Owner agrees to pay all costs and charges for special services requested.
3. Owner gives consent for emergency medical care as prescribed by a duly licensed veterinarian. This care may be given under any condition necessary to preserve life, limb, or wellbeing of the pet. Owner agrees to be solely responsible for any and all veterinary costs.
4. Owner agrees that the pet shall not leave the facility until all charges due are paid in full.
5. By signing the Contract and leaving the pet with Meow, Bark and Board, INC, Owner certifies to the accuracy of **all** information given about their pet and themselves. Meow, Bark and Board, INC reserves the right to deny admittance to Owner's pet for any reason at any time.
6. Meow, Bark and Board, INC will exercise reasonable care for the pet delivered by the Owner. The Owner agrees to be solely responsible any acts or behavior of pet while in the care of Meow, Bark and Board, INC. This includes payment of costs for injury to staff or other animals or damage to facilities caused by the pet.
7. Owner specifically represents that he or she is the sole owner of the pet, free and clear of all liens and encumbrances.
8. Owner specifically states that, to the Owner's knowledge, the pet has not been exposed to any communicable diseases within thirty days of check-in. During the period of this Agreement, Owner also agrees to notify Meow, Bark and Board, INC of any known exposure of pet to a communicable disease and hold pet out of attending Meow, Bark and Board, INC until pet is symptom free and/or without an elevated temperature for a minimum of ten days or with a written veterinary clearance. Owner further agrees to maintain currency of vaccinations as required by their veterinarian's policy. If pet displays any sign of illness while in the care of Meow, Bark and Board, INC, pet will be quarantined to a private suite, and Owner will be responsible for the extra charge.
9. All charges incurred by Owner shall be payable upon pick-up of pet. Meow, Bark and Board, INC shall have, and is hereby granted, a lien on the pet for any and all unpaid charges resulting from services provided. The Owner hereby agrees that in the event the charges are not paid when due in accordance with this Contract, Meow, Bark and Board, INC may exercise its lien rights upon seven days written notice given by Meow, Bark and Board, INC to Owner by certified mail to address shown on Contract. If Owner does not pick up pet or make contact with Meow, Bark and Board, INC within seven days of scheduled pick-up, it is in the sole discretion of Meow, Bark and Board, INC to dispose of the pet at public or private sale, and Owner waives all statutory or legal rights to the contrary. If such sale does not secure a price adequate to pay costs of pet care or other charges delinquent, plus cost of sale, then Owner shall be liable to Meow, Bark and Board, INC for the difference. All monies received by Meow, Bark and Board, INC at such sale, over and above the charges due and cost of sale, shall be paid to Owner.
10. Although Meow, Bark and Board, INC will take every possible precaution when caring for Owner's pet, it is recognized that the pet could be unpredictable, germs can survive in the cleanest facility and human error

can occur despite proper training, supervision and policies. Due to this, Meow, Bark and Board, INC its owners, employees, representatives, or any other person affiliated with the company shall not be held responsible for any health problems, illness or injury including death that may result from another pet or action of a Meow, Bark and Board, INC owner, employee, representative or visitor.

11. All terms and conditions of this Contract shall be binding by all parties.
12. Any controversy or claim arising out of or relating to this Contract, or the breach thereof, or as the result of any claim or controversy involving the alleged negligence by any party to this Contract, shall be settled in accordance with the rules of the American Arbitration Association. Judgment upon the award rendered by an arbitrator may be entered in any Court having jurisdiction thereof. The arbitrator shall, as part of the award, determine an award to the prevailing party of the costs of such arbitration and reasonable attorney's fees of the prevailing party.
